Subject: Corrigendum for Inclusion of 'Preference to Make in India' and Due Date Extension

Tender Title: Titanium Sponge Compacting Facility.

This has reference to subject Tender. The Corrigendum to the subject Tender is hereby issued. All participating bidders are requested to note the changes in respect of the above subject tender.

Preference to 'Make in India' Programme

In line with Public Procurement (Preference to Make in India) Order – 2017, to encourage 'Make in India' and promote manufacturing and production of goods and services in India, MIDHANI shall give Purchase Preference to those local suppliers having Local Content in their offers more than 10%.

For the purpose of above Purchase Preference, the following definitions are considered:

'Local Content' means the amount of value added in India which shall be the total value of the item procured (excluding domestic taxes) minus the value of imported content in the item (including all custom duties) as a proportion of the total value.

'Local Supplier' means a supplier or service provider whose product or service offered for procurement meets the minimum local content as prescribed above.

'L1' means the lowest tender or lowest bid as per the tender evaluation criteria.

The criteria for giving Purchase Preference is as below:

- a) Among all the qualified bids, if the lowest bid (L-1) is from a local supplier, the contract will be awarded to L1. If the L1 is not from a local supplier, the lowest bidder among the local suppliers will be invited to match the L1 price subject to local supplier's price falling within the margin of 20% and the contract shall be awarded to such local supplier subject to matching the L1 price.*
- b) In case the lowest local supplier fails to match the L1 price, the local supplier with next higher bid within the margin of 20% of the actual L1 price shall be invited to match the L1 price and so on and contract shall be awarded accordingly.*
- c) In case no Local supplier within the margin of 20% of the actual L1 price matches the L1 price, then contract shall be awarded to the L1 bidder.*
