3. Only Indian nationals may apply and age, qualification & experience stipulated above should be as on **16 Oct 2024**.
4. Candidates should mandatorily bring all the **original certificates and testimonials with one set of photocopies** thereof in support of date of birth (SSC certificate/Birth certificate), category, educational qualification (SSC or 10<sup>th</sup> certificate/ valid LMV or HMV Driving License/ Final Diploma Certificate/ ITI, NAC, proof of specialization/ trade/ percentage of marks/ consolidated mark sheets etc. [as per the requirement of the post]) with 2 **recent** colour passport size photographs.
5. Work experience certificates should invariably contain the details of service, work experience & time period. To establish your work experience, bring appointment letters, joining report, confirmation letters, increment letters, extension letters, promotion letters, latest salary slips, experience certificates etc. where the date of joining and relieving (as per applicability) can be distinctly established.
6. In addition to the work experience documents, candidates appearing for walk-in selection process **should mandatorily** produce documents pertaining to ESI & PF (as per applicability) or Salaried Account Statement (**for the no. of years of experience**) at the time of document/certificate verification process.
7. Document verification will be done initially for all the candidates. Candidates appearing for walk-in selection process without proper supporting documents / cases in which the requisite eligibility criteria cannot be distinctly established will not be considered and will be summarily rejected. No request in this regard will be entertained.
8. Candidates, who fulfil all the requisite parameters and QRs, shall only be allowed to appear for Written Test. Candidates qualified/shortlisted in the Written Test will be further called for Trade/Proficiency Test.
9. Candidates seeking reservation as EWS/OBC are required to **mandatorily bring the recent original EWS / OBC NCL certificate** regarding his/her "EWS / OBC Non-Creamy Layer (NCL) status" issued by the competent authority on the day of walk-in selection process.
10. Appearance of the candidates for Written Test/Trade Test/Proficiency Test will not entitle them to claim for contract engagement for the aforesaid posts. **Candidates will be debarred ab-initio at any stage of the recruitment process in case they do not fulfil the essential eligibility criteria.**
11. The upper age limit indicated above is for unreserved (UR) category. Age relaxation shall be applicable in accordance with the Govt. Of India orders issued from time to time.
12. 10% relaxation in respect of eligible qualification marks shall be given to SC candidates (applicable for posts at **Sl.No. 1** only i.e. Assistant Level-4 Metallurgy posts).
13. If the certificates verification / selection process cannot be conducted on the same day, it will be conducted on the next day or on a later date.
14. Subsequent to Written Test, Trade Test/Proficiency Test will also be conducted at a later date, to those candidates who are further shortlisted in the written test. If the written test / proficiency/trade test cannot be conducted on the same day, it will be conducted on the next day or on a later date.
