Dr. S. K. Jha holds a Doctor of Philosophy (Ph.D) in Engineering from Homi Bhabha National Institute. He is also a Metallurgical Engineering graduate from NIT Jamshedpur in the year 1988. He has worked for more than 27 years in Department of Atomic Energy (DAE). In Atomic Energy he has made number
		of technological innovations in processing of nuclear materials of different grades such as "difficult to hot work" Alloy. He has carried out Simulation and modeling of two dissimilar metals used for development of fusion technology. He has also developed Titanium half alloy and full alloy tube in different sizes for Light Combat Aircraft and PSLV applications. He has developed a process to develop unique properties in pressure tube; a life time component for nuclear power reactors.
