## **INVITATION TO TENDER**

#### **OVERVIEW:**

Mishra Dhatu Nigam Limited (MIDHANI), a Defence Public Sector company has been playing a very active role in development and manufacture of strategic materials for various sectors. MIDHANI is a unique integrated metallurgical plant located in Hyderabad, Telangana, INDIA. It has wide manufacturing facilities for manufacture of Special steels, Super alloys and Titanium alloys in various forms and sizes. Our annual turnover is about INR 815Cr (approx). ### 1. OBJECTIVE:

There is a potential requirement in domestic market for wider plates (>1500mm) of Super Alloys, Special Purpose steels and Titanium Alloys for various applications. A New facility is added for Manufacturing Wider Plates of Super Alloys, Titanium Alloys and Stainless Steels.

Midhani is interested to sell through distributors. In order to identify prospective buyers and to increase Midhani's market share in market, Midhani is inviting Leading Distribution agencies across various cities in India through this Expression of Interest.

### 2. ELIGIBILITY CRITERIA FOR APPLICANTS:

The bidders intending to bid for distributorship shall fulfil the following Pre Qualification criteria:

- (a) Shall be an Organization, Trading or Consulting Firm / Company who has experience in dealing in Plates for the last 3 years. Proof of experience to be submitted.
- (b) Turnover of minimum INR 5Cr per year in last 3 years ending with FY 2020-21. Audited Profit and loss account statement to be provided as proof. In case the audited balance sheet is not available for the FY20-21, certificate from CA shall be enclosed.
- (c) The Applicant should not be Blacklisted/Debarred by any Firm or any Government Organizations and companies. Self certification to be provided.

### 3. SCOPE ÷

Scope includes the following but not limited to


- (a) To understand Midhani's product mix and capabilities
- (b) Distributor shall service demand of identified customers/ dealers and enhance market share / reach in assigned geographical area/ cluster /product category
- (c) Market development activities, maintaining adequate sales force for arranging orders & assisting MIDHANI in brand building efforts

- (d) Extend Value added Services such as credit provision, door- step delivery for customers, cutting & packaging of MIDHANI products as required by end customer
- (e) Provide consolidated annual / half yearly / quarterly demand to Midhani for production planning & timely deliveries
- (f) To support Midhani in providing market intelligence
- (g) To co-ordinate with end users & Midhani to resolve quality issues, if any.
- (h) Other relevant works

### 4. OTHER INSTRUCTIONS:

- (a) If desired, Distributor can select one (or) more cities to market MIDHANI's wider plate.
- (b) If more than one Distributor applied for specific cities, depending on the credentials of distributor's, regions will be allotted. Midhani's decision will be final.
- (c) At the end of each financial year (ending March), progress of each distributors will be reviewed. If found unsatisfactory, their contract shall be terminated with immediate effect.
- (d) Upon selection as a Distributor, NDA to be signed followed by agreement along with the terms of reference.

### 6. PERIOD OF CONTRACT:

Period of contract shall be for 1 year. However Midhani reserves the right to extend the contract for one more year on the same terms and conditions.

The Distributor shall not be entitled to any compensation by reasons of such termination.

### 7. SUBMISSION OF DOCUMENTS ALONG WITH EOI:

The bidder qualifying the above Criterion shall submit the following documents

- (a) Company brochure
- (b) Certificates of Accreditations, if any
- (c) GST, PAN, TAN, etc.,
- (d) Application form as per Annexure I
- (e) Supporting documents indicating the past activities / records
- (f) Acceptance of all the tender conditions including scope of work
- (g) Documents required as per eligibility criteria

### 8. SUBMISSION OF BIDS:

To be done on or before Due date.

### 9. GENERAL TERMS & CONDITIONS:

- (a) MIDHANI reserves the right to accept or reject any Application/bid without assigning any reasons thereof.
- (b) Final Selection of the suitable Applicant/Applicants will be at the sole discretion of MIDHANI and it shall be final.
- (c) The selected Applicant/Applicants shall comply with all Government Regulations/Guidelines & Statutory requirements in force at any period in INDIA.
- (d) Eligible bidders are advised to study all the referred documents carefully before indicating Acceptance.
- (e) Validity of the offer/bid submitted should be 90 days from date of opening of bid.
- (f) Midhani reserves the right to modify the terms and conditions of this Tender and issue an amendment/corrigendum.

Any differences among the parties, in relation to this EOI, shall be resolved amicably through negotiation. In case of others – any dispute / unresolved differences shall be resolved settled by arbitration in accordance iw3th the international centre for alternative dispute resolution(ICADR) arbitration rules 1996. The authority to appoint arbitrator shall be the ICADR and will provide administrative services in accordance with ICADR arbitration rules 1996. The seat of arbitration shall be India, venue Hyderabad. The proceedings shall be in English. The decision of the arbitrator shall be final and binding on the parties. The applicable law shall be Indian laws only.

#### 11. JURISDICTION

The courts at Hyderabad shall have exclusive jurisdiction over all the matters of this EOI
