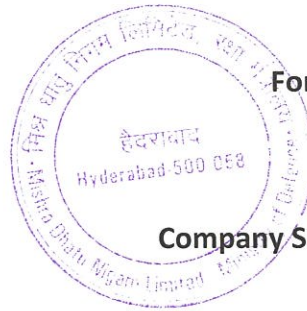

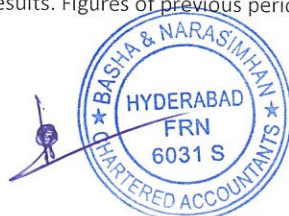

Notes:

- 1 The financial statements are prepared and presented in accordance with Indian Accounting Standards (Ind AS) [as notified under section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015], to the extent applicable, the provisions of the Companies Act, 2013 and these have been consistently applied.
- 2 Adoption of Ind AS 115- Revenue from Contracts with Customers:
Effective April 1, 2018, the company has adopted Ind AS 115 "Revenue from Contracts with Customers" using the cumulative effect method. The standard is applied retrospectively only to contracts that are not completed as at the date of initial application and hence the comparative information is not restated. The adoption of the standard did not have any material impact on the financial statements of the company.
- 3 Ministry of Corporate Affairs (MCA) has exempted the companies engaged in defence production from the requirement of Segment Reporting.
- 4 The Board of Directors at their meeting held on 30th May 2018 has recommended a sum of ₹ 393.79 million at ₹ 2.10 per share as dividend for the year 2017-18
- 5 The company has sub-divided the equity shares from face value of ₹ 1000/- per share to ₹ 10/- per share at the extraordinary general meeting of the Company held on 26th October 2017. Consequent to sub-division of shares, the earnings per share (EPS) have been adjusted for all the previous reported periods.
- 6 With the introduction of GST, w.e.f. 01.07.2017 Revenue from operations does not include taxes and duties whereas previous year figures included excise duty.
- 7 The figures of the quarter ended 31 March 2018 are the balancing figures between the audited figures of the full financial year 31 March 2018 and the figures upto the third quarter i.e. 31 December 2017.
- 8 As required under clause 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, the Statutory Auditors have conducted a limited review of the above financial results for the quarter and period ended 30th June 2018. An unmodified report has been issued by them thereon.
- 9 The above statement of financial results were reviewed by the Audit Committee and approved by the Board of Directors at the meeting held on 10th August 2018.
- 10 The previous period figures have been regrouped/reclassified, wherever necessary to conform to the current presentation.

This statement, which is the responsibility of the Company's management and has been approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" (Ind AS 34), prescribed under section 133 of the Companies Act 2013 read with relevant rules thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410. Review of Interim Financial Information performed by the Independent Auditor of the Entity, issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Mini-Ratna Defence PSU Mishra Dhatu Nigam Limited (MIDHANI) has achieved a Net Turnover of Rs. 106.02 Cr, during the 1st quarter of FY 2018-19, registering a growth of about 20.82 %, over the Net Turnover of Rs.87.75 Cr recorded in the corresponding period of the previous year.

Profit Before Tax (PBT) during the 1st quarter of FY 2018-19 stood at Rs. 21.19 Cr, registering a growth of about 21.78% over the Profit Before Tax (PBT) of Rs. 17.40 Cr recorded in the corresponding period of the previous year.
