**NOTICE** is hereby given to the Members of Mishra Dhatu Nigam Limited (“MIDHANI” or “the Company”) pursuant to Section 108 and 110 of the Companies Act, 2013 (“Act”) and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (the “Postal Ballot Rules”) read with the General Circular No. 3/2022 dated May 5, 2022 (in continuation to circulars issued earlier in this regard) issued by the Ministry of Corporate Affairs (“MCA Circulars”), the Resolutions set out in this Notice of Postal Ballot are proposed to be passed by the Members of MIDHANI through Postal Ballot only through e-voting process.

The instructions for e-voting are appended to this Postal Ballot Notice.

The Board of Directors of the MIDHANI, has appointed CS Navajyoth Puttaparthi (FCS: 9896; C.P. No. 16041) Company Secretary-in-Practice and Partner of M/s Puttaparthi Jagannatham & Co., Practicing Company Secretaries, Hyderabad, as the Scrutinizer for conducting the Postal Ballot through e-voting process in a fair and transparent manner. The Scrutinizer’s decision on the validity of vote(s) cast through e-voting process shall be final. You are requested to carefully read the instructions in this Postal Ballot Notice and record your assent (FOR) or dissent (AGAINST) through the e-voting process from 9:00 a.m (IST) Thursday, December 29, 2022 to not later than 5:00 p.m. IST on Friday, January 27, 2023, failing which it will be strictly considered that no reply has been received from the Member.

After completion of scrutiny of the votes, the Scrutinizer will submit his report to the Chairman of MIDHANI or a person authorized by the Chairman. 2. Select "EVEN" of company for which you wish to cast your vote during the e-Voting period.
3. Now you are ready for e-voting as the voting page opens.
4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on "Submit" and also "Confirm" when prompted.
5. Upon confirmation, the message "Vote cast successfully" will be displayed.
6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

**General Guidelines for shareholders:**

Ministry of Defence, Department of Defence Production vide Office Memorandum 8(32)/2019-D(Coord/DDP) dated November 10, 2022 conveyed the appointment of Shri Surendra Prasad Yadav, (Joint Secretary – Land Systems (JS-LS), Department of Defence Production, MoD, as Government Nominee Director on the Board of MIDHANI w.e.f. November 10, 2022. He will continue to hold office until further orders, conveyed by Administrative Ministry in this regard.

The Government Nominee Director on the Board of Company does not draw any sitting fees, commission or remuneration from the Company.

Shri Surendra Prasad Yadav shall not be liable to retire by rotation pursuant to Section 152 of the Companies Act, 2013.

Shri Surendra Prasad Yadav has completed his M.Tech and he is a 1996 batch Indian Forest Service (IFS) Officer of West Bengal cadre. He previously worked in Department of forest, Government of West Bengal in different capacities i.e. Divisional Forest Officer and Chief Conservator of Forest.
