1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

NOTE TO BIDDERS:

All pages of tender documents duly signed and stamped.

Unconditional Acceptance for All Technical and Commercial Terms and Buyer Added ATC Clauses.

Relevant Documents to be submitted as per Eligibility Criteria of tender.

INSPECTION: Dimensional inspection of machined parts shall be carried out on**duly calibrated CMM machine**. However, sub-contractor has to submit dimensional reports of machined components as per drawings.

IDENTIFICATION: Punching of Grade, Heat No, Part No, Part type etc. as per requirement of MIDHANI to be ensure d on the machined component.

<u>ACCEPTANCE CRITERIA</u>: Dimensions and tolerances of machined dies should be as per supplied drawings**In cas** e of minor Contour corrections / Press fitting corrections if any required during assembly is to be carrie d out one time by the sub-contractor at free of cost.

REJECTION: The machining has to be done as per scope of work and approved drawings. In case, if the component is rejected, the cost of raw material shall be recovered from the supplier as per MIDHANI purchase policy, and machi ning cost shall not be paid for the work carried out.

PROCESS LOSS: Generated scrap during machining should be kept separately and has to be returned to MIDHANI along with machined dies. However, a maximum of 10% process loss on generated scrap is acceptable.

DELIVERY PERIOD: Within 75 days from receipt of material from MIDHANI. Time is essence of this order.

SECURITY DEPOSIT (SD)- The successful tenderer/Bidder shall be required to furnish SD amount of 5% of purchas e order value within 21 days from the date of Purchase Order.

Note: If you are submitting Bank Guarantee (BG) in Place of SD, BG shall have a claim period of one year from the d ate of its expiry. In case SD is not submitted within 21 days from the date of PO, interest @ 12% pa shall be levied fo r the period of delay beyond 21 days.

PAYMENT TERMS: Within 30 days from the date of receipt and acceptance of material at MIDHANI.

REPEAT ORDER: The Purchaser may issue Repeat Order increasing the quantity upto 100% of original Purchase Or der quantity within two years from the date of original order and completion of original Purchase Order supplies subj ect to no downward trend in prices by giving reasonable time / notice to the Supplier.
