1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide

eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- Unconditional Acceptance for All Technical and Commercial Terms and Buyer Added ATC Clauses.
- ACCEPTANCE CRITERIA:** As per specification at Annexure-I.
- REJECTION:** The processing has to be carried out as per Scope of Work and as per Instructions given by MIDHANI after placement of order. In case any material is rejected due to non-conformity to scope of work or due to non-adherence of MIDHANI process instructions, cost for straightening shall not be paid and rejected material shall be returned back to MIDHANI/ the cost of the raw material will be recovered from the tenderer (wherever applicable).
- TRANSPORTATION:** To and Fro transportation shall be in the scope of vendor as per Annexure-I.
- DELIVERY PERIOD:** Supplier has to collect Roller from MIDHANI within 10 days from date of placement of PO. Straightening shall be completed with 4 weeks from date of issue of material. If material is not collected within 10 days from date of placement of PO then 10th day from placement of PO will be considered as date of issue of material.
- SECURITY DEPOSIT (SD):** The successful tenderer/Bidder shall be required to furnish SD amount of 5% of purchase

e order value within 21 days from the date of Purchase Order.

Note: If you are submitting Bank Guarantee (BG) in Place of SD, BG shall have a claim period of one year from the date of its expiry. In case SD is not submitted within 21 days from the date of PO, interest @ 12% pa shall be levied for the period of delay beyond 21 days.

8. **PAYMENT TERMS:** Within 30 days from the date of receipt and acceptance of material at MIDHANI.
9. **REPEAT ORDER:** The Purchaser may issue Repeat Order increasing the quantity upto 100% of original Purchase Order quantity within two years from the date of original order and completion of original Purchase Order supplies subject to no downward trend in prices by giving reasonable time / notice to the Supplier.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
