Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide

eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- 3. ACCEPTANCE CRITERIA: As per specification at Annexure-I.
- 4. **REJECTION:** The processing has to be carried out as per Scope of Work and as per Instructions given by MIDHANI a fter placement of order. In case any material is rejected due to non-conformity to scope of work or due to non-adher ence of MIDHANI process instructions, cost for straightening shall not be paid and rejected material shall be returned back to MIDHANI/ the cost of the raw material will be recovered from the tenderer (wherever applicable).
- 5. TRANSPORTATION: To and Fro transportation shall be in the scope of vendor as per Annexure-I.
- 6. **DELIVERY PERIOD:** Supplier has to collect Roller from MIDHANI within 10 days from date of placement of PO. Straig htening shall be completed with 4 weeks from date of issue of material. If material is not collected within 10 days from date of placement of PO then 10th day from placement of PO will be considered as date of issue of material.
- 7. SECURITY DEPOSIT (SD)- The successful tenderer/Bidder shall be required to furnish SD amount of 5% of purchas

e order value within 21 days from the date of Purchase Order.
